

Accordingly, we have acquired with the MOOT COURT EXERCISE AND INTERNSHIP for the final year. Under this subject we had an opportunity to visit, observe and acquire practical knowledge of Civil Court, Criminal Court, Labour Court and Advocate Chamber etc.

The main objects of this subject are to acquire the practical knowledge, to observe procedure of the court, to get acquainted and familiar with the documentation from filing of the suit to the decree.

From 11st to 20th March 2019, Students of III rd. LLB of OLD course from the esteemed SHAHAJI LAW COLLEGE KOLHAPUR coming under SHIVAJI UNIVERSITY KOLHAPUR visited KAGAL CIVIL AND CRIMINAL COURT located at Kagal for observing Criminal Court proceedings under the guidance of Professor Dr. M. C. Sheikh.

We observed the court building and gained the knowledge about how many court rooms and allied offices are there on first and second floor besides well-equipped library. The ground floor is largely occupied by Advocate Bar, Public Prosecutor, E-Centre, Canteen etc. Then we starting observing the courts and its proceedings, first we read the Board containing a list of cases for the day which is placed on the wall outside the court room.
